

Contextual Integrity

- Privacy is provided by appropriate flows of information.
- Appropriate information flows are those that conform with contextual information norms
- Contextual informational norms refer to five independent parameters: data subject, sender, recipient, information type, and transmission principle
- Conceptions of privacy are based on ethical concerns that evolve over time

Contextual Integrity Modeling

- 1. The data subject
- 2. The sender of the data
- 3. The recipient of the data
- 4. The information type
- 5. The transmission principle.

Contextual Integrity Modeling Example

- Actors: Subject, Sender, Recipient
- Information Type
- Transmission Principle

Contextual Integrity - Appropriate Flow

- Conforms with norms (rules) and meets expectations
 - Discover what those norms are through modeling (all possible) situations
- Legitimate, worth defending, morally justifiable
 - Interests of individuals parties affected
 - Ethical values
 - Contextual purposes, functions values

Contextual Integrity - Contextual Purposes

Healthcare - cure disease, alleviate pain, prevent death

Politics - democracy, autonomy, justice

Home and social - trust, stability, support

Education - knowledge, creativity, intellect


